



Information about the Szczecin Fair Play Regatta POLISH – GERMAN FINN MASTERS CHAMPIONSHIP Szczecin, 01-04.08.2019

1. ORGANIZER

1.1. The Organizer of the regatta is the Sailing Center, ul. Przestrzenna 19, 70-800 Szczecin, Poland, and the Polish Finn Association. The Organizer has a licence of the Polish Sailing Association to organize the regatta.

1.2. The regatta takes place on lake Dąbie on 01-04.08.2019.

2. REGULATIONS

The Regatta follow:

- provisions of the WS 2017-2020 Sailing Regatta Regulations;
- regulations of the International Finn Association;
- Sailing Instruction;

In case of conflict between the said documents, English version shall prevail.

4. REGISTRATION

- 4.1 To participate in the regatta, contestants are required to present the following documents together with their registration form:
 - civil liability insurance (boat or helmsman with extension for "period of
 - regatta");
 - yacht certificate;
 - approval by the official measurer;
 - payment of participation fee.

Przestrzenna 19, Szczecin). Payment confirmation should be presented on registration.

6. SAILING INSTRUCTION

After the completion of the registration procedure, the Sailing Instruction will be available at the Regatta Office.

7. MEASUREMENTS

Control measurements as specified in regatta and class regulations can be made at any moment during the regatta.

8. POINT SYSTEM

8.1 The Regatta is considered valid provided at least 3 races have been completed.8.2 In the case of less than 4 races, all results of a yacht in the race series are included in the final calculation of points. In the case of 4 and more races, the poorest result is disregarded.

9. ENVIRONMENTAL PROTECTION

A yacht which dumps waste into water may be penalised by the decision of the Regatta Committee or the Appeal Team after processing of a complaint.

10. COACH AND OBSERVER BOATS

All motorboats used by coaches and observers participating in the regatta need to be accredited during the registration procedure.

11. RIGHT TO IMAGE

While applying to participate in the regatta, the contestant agrees to a charge-free use of his/her image by sponsors and organizers in photographs, films and other copies during the regatta and in all materials applicable to the regatta and the activity of the Sailing Center. It is mandatory to place organizer's advertising materials on yachts participating in the regatta.





12. LIABILITY

All participants take part in the regatta at the own risk. No activity performed or omitted by the organizer frees regatta participants from their liability for damage caused by a contestant or his/her yacht during the regatta.
